The Applicant authorizes Tisa Canada Corp. to contact any credit reference given, Banks and Credit Bureaus, to release and exchange such credit, banking or financial information as may be necessary to determine credit standing. The Applicant also grants permission to the trade and bank references listed to impart financial information requested by Tisa Canada Corp. or its agents, in the course of regular credit investigation. The Applicant agrees that subsequent credit information may be obtained throughout the duration of the business relationship and consent to the release of the said information. Credit given for goods delivered becomes due 30 days after delivery, failing which the Applicant shall be deemed in default and Tisa Canada Corp. shall have the option of exercising any or all of the following remedies: a) termination of this Agreement; b) interest shall be added at 2% monthly, calculated and compounded monthly, (26.82% annually) from date of delivery to date of payment, and any outstanding interest shall be satisfied before any payment monies are applied to the principal balance; c) any delivery of goods to be cash on delivery until the default is cured and until the Credit Agreement is reinstated in writing, if it was terminated; d) Tisa Canada Corp. may use any other method of collection and enforcement of its rights prescribed by Ontario law, including, but not limited to, Court action, seizure and sale of goods and property and garnishment, and the Applicant shall be obligated to pay any and all of Tisa Canada Corp.'s legal expenses to enforce this Agreement on a "substantial indemnity" basis. The Applicant acknowledges that this Agreement is more than just a promise to make payment of the debt due to Tisa Canada Corp. under the terms of this Agreement. This provision constitutes the Applicants GUARANTEE OF PAYMENT, which the Applicant is supporting with a pledge of collateral security in the Applicant's personal property. The Applicant acknowledges that this Agreement constitutes a GENERAL SECURITY AGREEMENT within the meaning of the Personal Property Security Act of the Province of Ontario, as amended from time to time. This security includes goods, equipment, inventory, accounts and personal property of the Applicant. The Applicant and the undersigned hereby certify that the information in this Application/Agreement is true and correct; the undersigned also certifies that he/she is authorized to sign for and bind the Applicant. The Applicant and the undersigned acknowledge that this contract was completed in Windsor, Ontario and they agree that Windsor Courts shall have sole jurisdiction for enforcement of Tisa Canada Corp.'s rights herein. Returned goods, if accepted by us, are subject to a 20% restocking charge.
